 - Question 1. What are some innovative ways that diverse businesses can promote sustainability and engage with employees, customers, and communities on this important issue?
 - A. Professor Bresnahan, Discussed the domino effect of positive change in sustainability.

- B. Florence, Shared the need of organizations to embrace mission with passion and to report funding outcomes.
- C. Mika, Discussed organizational responsibility to meet employees where they are and develop competencies on verbiage.
- 3. Question 2. What are some key challenges businesses and entrepreneurs face when trying to incorporate sustainability practices into their workforce and operations? How do we combat these challenges?
 - A. Professor Bresnahan, Emphasized the importance of having the right tools to understand the language of sustainability, such as green technology and green finance. Professor Bresnahan noted that sometimes, the terminology and concepts related to sustainability can be complex and unfamiliar to businesses and entrepreneurs. Therefore, providing them with accessible resources and educational materials can help bridge this gap and facilitate smoother integration of sustainability practices into their operations.
 - B. Mika, focused on synchronization among entities. By working together and fostering synergy among stakeholders, businesses and entrepreneurs can effectively combat the challenges associated with integrating sustainability into workforce and operations.
- 4. Question 3. What do you find to be some of the greater challenges when recruiting prospective workers in underserved communities and appropriately tailoring workforce pathways in the sustainability field to these workers? What resources and support might they benefit from?
 - A. Florence, Emphasized the importance of encouraging individuals to enter the industry due to lucrative nature, financial opportunities, and potential for substantial growth. Florence noted diverse opportunities for career advancement, high demand for skilled professionals, and potential for long-term success.
- 5. Question 4. Looking towards the future, what are some predictions for how policy related to sustainability will evolve and how it will shape the business landscape?
 - A. Professor Bresnahan, Discussed the significance of observing sustainability initiatives from an executive-level perspective, considering financially viable, leading to positive cash flows and a favorable return on investment. When financial benefits are highlighted, executives can be more inclined to support and allocate resources to sustainability projects.
 - a. Governments can incentivize businesses to adopt sustainable practices by offering tax credits and other financial incentives.

 - A. Lujuana Medina, Division Manager, SoCalREN
 Q: Inquired about how-to help students follow through with programs.
 A: Mika, Delved into the crucial role of Social Emotional Learning (SEL) in workforce development initiatives. She emphasized that facilitators and educators involved in training programs need to be highly aware and attuned to SEL principles and practices.

- Q. Requested the Panel's participation in upcoming LAWA Girls Camp (sponsored by Mayor Karen Bass) aimed at involving youth in Architecture, Engineering, and Construction career pathways.
- C. Minh Le, Highlighted the transition from coal miners to Green Jobs as an example of the shifting landscape and opportunities within the workforce. Le emphasized the importance of visualizing these changes across the entire County to inspire and inform future workforce initiatives.
- D. Dean Chito Cajayon, Los Angeles Trade Tech, Discussed the strategic theme of collaboration and alignment with DEO in the development and implement of effective strategies to support workforce development and economic growth in the region.

IV. Advancing Digital Equity and Inclusion

- a. Rebecca F. Kauma, Director of Digital Equity, County of Los Angeles ISD
 - Kauma, as the First Director of Digital Equity for the County of LA, shed light on the critical issue of limited access to Wi-Fi and computers, emphasizing the necessity of partnerships with key leaders to bridge this digital gap.
 - 2. Digital Equity stands as the ultimate objective.
 - She outlined the activities and focus areas of her department, such as the IBCC initiative, with notable contributions from Caroline Torosis, Senior Deputy, Workforce Development & Economic Opportunity from LA County Supervisor Holly Mitchell's Office. Allocated funding aims to tackle the digital divide.
 - 4. The co-development process entails specific duties and scopes of work, coordinated through working groups like Asset Mapping, as detailed in the provided presentation materials.

 - 1. E-Contractor Program and Building Decarbonization Pilot Academy
 - A. The academy operates in collaboration with SoCal Edison and SoCal Gas to ensure comprehensive training and support for contractors.

 - A. Contractors will receive in-depth training on the latest green building technologies, focusing on sustainable construction practices.
